Your Tariff

Effective from 1 February 2022

Your Tariff sets out the prices we charge you. If we provide any other chargeable service that isn't included on this Tariff, we'll tell you the charge before we provide the service to you. We refer to your Tariff in our Silicon Valley Bank UK Banking Terms and Conditions and it applies only to accounts held with Silicon Valley Bank UK. Terms defined in Silicon Valley Bank UK Banking Terms and Conditions will have the same meaning in this Tariff.

Free Banking

Benefit from free Banking for 60 days or more if you've just opened your first account with us.

This means you won't pay any charges for any services you use during this period, with the exception of Debit Card charges and Unauthorised Overdraft fees and interest.

Free Banking applies to your first account only. Charges for this account will begin from the first calendar day of the month after 60 calendar days have passed from the date you opened the account.

BILLING CYCLE: OUR BILLING CYCLE IS MONTHLY.

After the billing cycle ends on the last UK Business Day of each month, we'll provide you with a billing notice that sets out the services you've used in that billing cycle, along with a calculation of the charges you're due to pay. You'll receive separate billing notice for each of your accounts.

We'll apply the total amount charged as stated on your billing notice 21 calendar days from the end of the related billing period. We'll deduct it either from the account the charges apply to or from an alternative account if you've instructed us to.
